# SHOW INFORMATION

## GENERAL

**CHECK IN/BENCHING:** Saturday check in is 7:30am – 8:30am.  
**JUDGING:** Judging begins at 9:00am on Saturday and Sunday.  
**OFFICIAL SHOW HOURS:** Saturday hours are 9:00am – 5:00pm and Sunday hours are 9:00am – 4:00pm.

*No cats will be permitted to leave the show hall during official posted show hours with permission of show management.*

*No cats or kittens allowed in show hall overnight*

## ENTRY and PAYMENT

- **Entries accepted** starting December 1, 2019.
- **Entries close** on January 21, 2020 @ 5:00pm (CDT)
- All entries **MUST** be paid in full within 10 days of the receipt of entry or **PRIOR** to the start of the show, whichever is first as per **CFA Show Rule 6.21**.
- PayPal payments can be made by sending to: [info@birminghamfelinefanciers.com](mailto:info@birminghamfelinefanciers.com).
- If paying by check, make check payable to BIRMINGHAM FELINE FANCIERS and send to the Entry Clerk. There is a \$50 returned check fee.
- **REFUNDS:** No refunds or substitutions may be made after closing date. No refunds will be given for failure to bench.

- End of row is free to handicapped exhibitors (must request when submitting entry form).
- All entries include \$2 CFA surcharge.
- No kittens under the age of four months will be allowed in show hall.
- No declawed entries are permitted.
- Sales cages only available with paid entries.
- By entering exhibitors agree to abide by the decisions of the judges and the show committee and to adhere to CFA Show Rules. Printed copies of CFA Show Rules may be obtained for \$7.00 each plus shipping from CFA, 260 East Main Street, Alliance OH 44601; electronic copies are available on the CFA web site.
- Use of ANY SIZE security cage will require the purchase of a double cage (extra ½ double cage for entered cat). The size of a single cage (1/2 cage) is approximately 22" x 22" x 22".

## SCORING INFORMATION

**SCORING:** All entries in Championship (except Novice) and Premiership (except Novice), *registered* Kittens, recorded HHPs and registered cats competing as HHPs with a Household Pet color class prefix will be scored for CFA awards.

Owners of unregistered kittens and novices can contact the entry clerk for a temporary registration number.

## MISCELLANEOUS INFORMATION

- All claws of all entries must be clipped prior to benching.
- The show hall is heated and air-conditioned.
- Neither the Club nor Zamora Temple is liable for loss of property, damage, or accidents to cats or to exhibitors.
- Smoking not permitted where cats are benched or judged.
- It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calici virus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. **The State of Alabama requires Rabies vaccinations.**
- The show committee reserves the right to remove any cat or kitten from the show hall if suspected of having any of the listed ailments until examined by a licensed veterinarian at the owner/agent's expense.
